

**Per Diem Rates FY25**

Per Diem rates include the following costs: daily health observations; cages changed every 2 weeks; standard daily diet (food/water); standard bedding (see additional charges); cage, equipment and facility sanitization; PPE (sterile gowns, non-sterile gloves, head covers, facemasks) for husbandry and research staff; sentinel program; routine medical treatment per SOP #9; general operating expenses for husbandry (cage cards, office supplies, salaries) and related administrative costs.

| <b>Technical Services</b>  |  |
| Technical services include tasks performed outside of the standard husbandry duties: maintaining breeding colonies, ear tagging, tail snipping, weaning, assisting with technical procedures, euthanizing. Time is charged in 15 minutes increments. Consumable goods include items used in the support of research (sterile gloves, syringes, scapel blades, reagents, gauze, Medigel, medications). Import/Export fees are for shipments arranged between non-commercial vendors and other universities. |  |

| Labor (Veterinary Technologist)  | \$29/hr & \$43/hr for Overtime                             |
